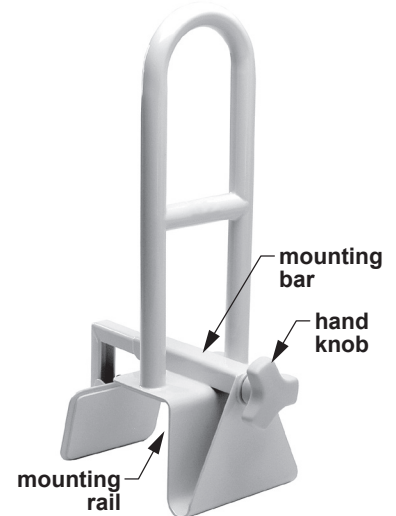


- ⚠ **WARNING: Important! Read and understand these instructions before installing or using the 2032A Sure-Safe[®] Bathtub Rail. If you do not understand any part of these warnings, cautions or instructions, contact a healthcare professional for direction in the use of this product. If the Bathtub Rail is not properly assembled and adjusted, personal injury and damage to the Bathtub Rail could result.**
- ⚠ **WARNING: If components are damaged or missing, contact your dealer immediately. DO NOT use substitute parts. Use only Lumex replacement parts. Non-Lumex replacement parts could cause personal injury and damage to the Bathtub Rail.**
- ⚠ **WARNING: This product has a weight limit of 250 lb (113 kg), EVENLY DISTRIBUTED.**
- ⚠ **WARNING: This product is NOT recommended for use on fiberglass or plastic bathtubs. GF Health Products, Inc. ("Graham-Field") assumes no responsibility for any damage or injury caused by improper assembly or use of this product.**

INSTALLATION

- ⚠ **WARNING: DO NOT overtighten Bathtub Rail.**
1. Locate section of bathtub wall where Bathtub Rail is to be mounted. The Bathtub Rail should be mounted ONLY on the straight — not curved — part of bathtub wall. Ensure the tub surface where the Bathtub Rail will be installed is smooth, clean, and dry before installing the Bathtub Rail. Remove any dust, powder, or foreign particles.
 2. Use the hand knob to loosen the mounting bar until it is wide enough to fit your bathtub.
 3. Place the Bathtub Rail in the desired location on the bathtub.
 4. Turn the hand knob clockwise until the Bathtub Rail is secure on the bathtub.
 5. Test installation security by giving a strong pull to the Bathtub Rail in a lengthwise direction to the bathtub. If the Bathtub Rail moves, reset it and tighten it more.

- ⚠ **WARNING: Ensure the Bathtub Rail is installed as described before use.**

OPERATION

- ⚠ **WARNING: Always ensure the Bathtub Rail is secure before use.**
- ⚠ **WARNING: Hold the Bathtub Rail firmly when entering or exiting the bathtub.**

MAINTENANCE / CLEANING

- ⚠ **WARNING: Check the Bathtub Rail weekly for signs of damage or cracking. If damage or cracking of any component of the Sure-Safe[®] Bathtub Rail is found, DO NOT use the Bathtub Rail. Contact your Graham-Field authorized distributor.**

Inspect the Bathtub Rail weekly and tighten it as needed to ensure proper installation.

To clean the Bathtub Rail, wash it with soap and water or a mild detergent, then rinse. Ensure the Bathtub Rail is rinsed well before use.

LIMITED WARRANTY

SCOPE OF WARRANTY

GF Health Products, Inc. ("GF") warrants to the Original Purchaser only that it will replace or repair components, at GF's sole discretion, that are defective in material or workmanship under normal use and service. All warranties are conditioned upon the proper use of the products strictly in accordance with good commercial practice and applicable GF instructions and manuals, including proper use and maintenance. To the extent that a third party warrants a component, GF conveys all of its rights under that warranty to the Original Purchaser, to the extent permitted. Original Purchaser is one who purchases this product new and unused from GF or a Certified GF Dealer/Distributor.

This limited warranty shall only apply to defects that are reported in accordance with the provisions set forth in this warranty document, within the applicable warranty period and which, upon examination by GF or its authorized representative, prove to be a warranty item. (See Obtaining Warranty Service below) This limited warranty is not transferable.

The warranted components and time periods are set forth below:

Bathtub Rail:.....3 years

*Labor is not included in the warranty.

†The warranty period is as designated above. If a part is replaced under warranty, the original warranty period will not be affected. All other replacement parts will be subject to the warranty period specified.

The applicable warranty period shall commence from date of shipment to the Original Purchaser, unless there is an expiration date on the component in which case the warranty shall expire on the earlier of warranty period or the expiration date.

OBTAINING WARRANTY SERVICE

Contact the Dealer/Distributor from whom the product was purchased. If there is not a Dealer/Distributor, you must contact GF directly by calling (770) 368-4700, sending a fax request to 770-368-4932 or by e-mailing a request to cs@grahamfield.com. The Customer Service Representative will provide specific directions. Failure to abide by the specific directions will result in denial of the warranty claim.

EXCLUSIONS

The warranty does not cover and GF shall not be liable for the following:

- 1) Defects, damage, or other conditions caused, in whole or in part, by misuse, abuse, negligence, alteration, accident, freight damage, tampering or failure to seek and obtain repair or replacement in a timely manner;
- 2) Products which are not installed, used, or properly cleaned and maintained as required in the official manual for the applicable product;
- 3) Products considered to be of a non-durable nature including, but not limited to: filters, fuses, gaskets, lubricants, and charts;
- 4) Accessories or parts not provided by GF;
- 5) Matching of color, grain or texture except to commercially acceptable standards;
- 6) Changes in color caused by natural or artificial light;
- 7) Charges by anyone for adjustments, repairs, replacement parts, installation or other work performed upon or in connection with such products which are not expressly authorized in writing, in advance, by GF;
- 8) Any labor or shipping charges incurred in the replacement part installation or repair;
- 9) Costs and expenses of regular maintenance and cleaning; and
- 10) Representations and warranties made by any person or entity other than GF.
